What is SEPHIENCE?

SEPHIENCE™ (sepiapterin) is a prescription medicine used to lower blood levels of phenylalanine (Phe) in adults and children 1 month of age and older with a certain type of Phenylketonuria (PKU). SEPHIENCE is used along with a Phe-restricted diet. It is not known if SEPHIENCE is safe and effective in children younger than 1 month of age.

What is the most important information I should know about SEPHIENCE?

SEPHIENCE may cause serious side effects, including:

- increased bleeding problems. SEPHIENCE may increase your risk of bleeding. Tell your healthcare provider if you develop any symptoms of bleeding including:
 - bruising or red or purple skin marks
 - menstrual bleeding that is heavier than normal
 - bleeding longer than usual or that does not stop
- · low blood Phe (hypophenylalaninemia). Low blood Phe levels are common during treatment with SEPHIENCE and can be severe.

Navigating life with PKU

Living with Phenylketonuria—better known as PKU—comes with daily challenges, like managing phenylalanine (Phe) levels. SEPHIENCE is used to help manage Phe levels in people with PKU, as part of a Phe-restricted diet, allowing you to focus on what's important to you.

What is PKU?

PKU is a genetic disorder characterized by the body's inability to break down an amino acid called Phe. When we consume high-protein foods, the body breaks it down into smaller components like amino acids. In people with PKU, the body has trouble processing Phe properly, causing it to build up in the blood—which can lead to irreversible brain damage and other serious health problems.

What's it called when Phe is high?

It's called hyperphenylalaninemia when too much Phe builds up in the blood.



What's the recommended Phe range?

Experts recommend keeping Phe ≤360 µmol/L (≤6 mg/dL) for lifelong brain health.



Diet matters. People with PKU need to avoid high-protein foods like meat, fish, eggs, dairy products, and nuts, as these can raise Phe levels.



What is SEPHIENCE™?

SEPHIENCE is a prescription medicine used along with a Phe-restricted diet to lower blood levels of Phe in adults and children 1 month of age and older with PKU. It contains sepiapterin, which your body converts into tetrahydrobiopterin (BH₄)—a key molecule that supports the enzyme that breaks down Phe and reduces its buildup.

Results with SEPHIENCE

SEPHIENCE was studied in APHENITY, a two-part clinical trial of people aged 1-61 years old living with PKU. During Part 1 of the trial, 156 participants received their age- and weight-specific dosage. In Part 2 of the trial, a total of 98 people with PKU, aged 2 years and older, who responded to SEPHIENCE in Part 1 were randomly assigned to receive either SEPHIENCE or a placebo for 6 weeks.

Additional results with SEPHIENCE

Results across different types of PKU

As part of the APHENITY study, SEPHIENCE was studied in people with different types of PKU, including those with classical PKU and those who had not responded to BH, treatment in the past.

Classical PKU is the most severe form of PKU. People with classical PKU have had very high levels of blood Phe (≥1200 µmol/L) at some point in their lives, even if their levels are lower now.

In both groups, SEPHIENCE significantly lowered the amount of Phe in the blood, showing it worked across a wide range of people with PKU.

For people with classical PKU

Blood Phe was reduced by

69%

For people not helped by BH₄ treatment in the past

54%

These findings help demonstrate the potential for SEPHIENCE to support people with PKU regardless of prior treatment experience or PKU type.

Achieving recommended Phe levels

SEPHIENCE™ was studied to see how well it helps people with PKU reach blood Phe level targets recommended by experts. These targets, set by the American College of Medical Genetics and Genomics, recommend maintaining a blood Phe level of ≤360 µmol/L (or ≤6 mg/dL).

In the APHENITY trial:

84%

of participants taking SEPHIENCE reached that expert-recommended target

9% of participants who took placebo achieved the same goal

Maintaining Phe levels within this recommended range is important for supporting brain development and long-term cognitive health.

Additional results with SEPHIENCE

APHENITY Extension Study: Effects on diet in PKU

Following the APHENITY clinical trial, this extension study looked at the long-term safety and potential benefits of SEPHIENCE. The goal was to see if SEPHIENCE could help people eat more natural protein while keeping their blood Phe levels in a healthy range.



Who took part?

As of the data cutoff date of September 2, 2024, a total of 169 people with PKU joined this study. Participants ranged in age from ~2 months to 55 years old, with a median age of 14. Some people had taken part in the original APHENITY trial, while others were new to SEPHIENCE. This study is still in progress, and the results shown are based on the data collected up to the cutoff date.

How did the study work?

- Everyone took SEPHIENCE once a day for at least one year
- 169 participants were divided into two groups based on their blood Phe levels at the start



- -Those with lower Phe levels (<360 µmol/L, n=102) were guided through a diet assessment period, where healthcare providers slowly increased the amount of natural protein they could eat, adjusting the diet every two weeks over 26 weeks
- -Those with higher Phe levels (≥360 μmol/L, n=49) continued on treatment without diet changes, but all participants had regular check-ins throughout the study

With SEPHIENCE™, many people were able to eat more natural protein

After 26 weeks of treatment, researchers examined changes in the amount of natural protein participants in the dietary assessment group were able to consume relative to their baseline. **Here's what they found:**



increased their dietary Phe intake

With SEPHIENCE, nearly all participants could relax their diet and increase Phe intake during the 26-week assessment period.



met their daily recommended protein needs

Two out of three participants met their age-adjusted natural protein needs while on SEPHIENCE.



of protein per day

With SEPHIENCE, a 110-lb person could consume approximately 60 grams of natural protein per day after 26 weeks of treatment.

Study limitations:

This study is "open-label," meaning both the researchers and participants knew what treatment was being given. Also, participants reported their own protein intake, which may not always be exact. Sometimes diary records were incomplete. Because people of various ages participated and had different starting diets, this may impact our understanding of the results. The APHENITY Extension Study cannot say for sure whether people with PKU can fully relax their diet. However, it shows that SEPHIENCE continues to work over the long term to keep blood Phe levels below 360 µmol/L (6 mg/dL), which for some adults and children with PKU may mean being able to ease dietary restrictions. What to expect with SEPHIENCE

SEPHIENCE has been shown to provide effective management of Phe levels in clinical trials of people with PKU spanning a range of age groups.

SEPHIENCE may cause serious side effects, including an increased risk of bleeding or bruising. One person in the APHENITY trial experienced non-life-threatening bruising and prolonged bleeding, which resolved after treatment was discontinued. Contact your healthcare provider if you notice any unusual bleeding. In children with PKU, it can sometimes cause very low levels of Phe in the blood, so regular monitoring is important. For those taking levodopa, your healthcare provider should monitor for any side effects such as seizures, irritability, or feeling overly stimulated.

Side effects with SEPHIENCE may affect each person differently. Information on the long-term use of SEPHIENCE is limited.

Once-daily dosing

Taking SEPHIENCE

- Take SEPHIENCE once a day, with food
- -Additional food intake is required after dosing
- It's best to take SEPHIENCE at the same time each day
- Your healthcare provider will tell you the right dose based on your (or your loved one's) body weight and age

Mixing SEPHIENCE

- Comes in 250 mg and 1000 mg powder packets
- Mix with water, apple juice, or soft food (only for doses ≥1000 mg) like applesauce or strawberry iam
- May cause staining when in contact with certain surfaces. To minimize this risk, use as directed



Follow these steps to take SEPHIENCE



Prepare

Mix the correct number of packets with water, apple juice, or soft food (only for doses ≥1000 mg), such as applesauce or strawberry jam. These mixing options were studied in clinical trials. For additional mixing options, please check with your healthcare provider.



Mix until combined

- Stir liquids for at least 30 seconds
- Stir soft foods for at least 60 seconds

Note: Oral powder is not expected to dissolve completely. This is normal.



Use as directed

- Drink or swallow the full amount
- For doses <1000 mg: Use an oral syringe to draw up the prescribed dose and administer



Rinse & finish

- Rinse the cup or syringe with water or juice
- Swallow the rinse until clean to make sure you get the full dose



If you need to store it

- If not taken right away, cover and store the mix:
 - -In the refrigerator (36°F to 46°F/2°C to 8°C) for up to 24 hours
 - -At room temperature (68°F to 77°F/20°C to 25°C) for up to 6 hours
- Stir again before using (see step 2) for at least 30 to 60 seconds
